

# T&C'S - CHRISTMAS RAFFLES

These Terms and Conditions ("Agreement") govern the Christmas Toy Raffle (the "Raffle") conducted by SOPO ("the Company"). By participating in the Raffle, you agree to comply with these Terms and Conditions. Please read this Agreement carefully.

## 1. RAFFLE DETAILS:

- 1. The Christmas Toy Raffle is a single raffle event with a total prize pool exceeding \$5,000.
- 2. There is no limit to the number of entries that individuals may purchase.
- 3. Staff members of SOPO are eligible to purchase Raffle tickets.

### 2. TICKET PRICES:

Raffle tickets are available for purchase, with prices starting from \$2 per ticket.

## 3. PRESENCE NOT REQUIRED:

Participants do not need to be present at the drawing to win a prize.

## 4. DRAWING DATE AND TIME:

- 1. Draws for the Raffle will commence from 5:30 pm on December 7th.
- 2. All prizes will be drawn on the same day, and no redraws will be conducted for any prizes.

## 5. PRIZE STRUCTURE:

- 1. The Raffle will consist of four tables of prizes.
- 2. Each table will feature nine minor prizes from which winners may select their prize on a "first in, best dressed" basis.
- 3. Once the minor prizes of each table are allocated, a major prize draw will be conducted.
- 4. The major prizes will include the following: Xbox Series S, Playstation 5, Nintendo Switch, Oculus Quest
- 5. All unallocated minor prizes will be randomly selected and assigned to the winners that are not present.

# 6. PRIZE ALLOCATION:

- 1. Winners of the Raffle may choose their minor prize from the table at which their ticket is drawn.
- 2. Major prize draws will take place once all minor prizes have been allocated from each table.

#### 7. NOTIFICATION OF WINNERS:

- 1. Winners of the Raffle will be notified by the Company.
- 2. The Company will make reasonable efforts to contact and inform winners.



## 8. ACCEPTANCE OF PRIZES:

- 1. Prizes are to be accepted as awarded and are not transferable or redeemable for cash.
- 2. The Company is not responsible for any expenses or costs associated with the acceptance and use of Raffle prizes.

## 9. MODIFICATION AND TERMINATION:

- 1. The Company reserves the right to modify, suspend, or terminate the Raffle at any time without notice.
- 2. In the event of program termination, participants will have no further claim against the Company.

## 10. GOVERNING LAW AND DISPUTES:

- 1. These Terms and Conditions shall be governed by and construed in accordance with the laws of Queensland.
- 2. Any disputes arising out of or relating to this Agreement or the Raffle shall be subject to the exclusive jurisdiction of the courts located in the jurisdiction where SOPO is located.

By participating in the Christmas Toy Raffle, you acknowledge that you have read, understood, and agreed to be bound by these Terms and Conditions. If you do not agree to these terms, please do not participate in the Raffle.
